Duke Energy Foundation awards \$21,730 to Communities In Schools of Clark County to support Afterschool STEM Programming at 4 Elementary Schools

Jeffersonville (December 2, 2016) – Duke Energy Foundation has awarded a grant of \$21,730 to Communities In Schools (CIS) of Clark County. The grant is being used to bring STEM (Science, Technology, Engineering, and Mathematics) programming to students enrolled in CIS's Extended Day Learning afterschool program at 4 high-needs elementary schools during the 2016-2017 school year. Funding will also provide professional development in STEM teaching to all CIS Afterschool staff.

The grant will be used for:

- 9 weeks of STEM programming at each of 4 high-need elementary schools: Parkwood, Wilson, Bridgepoint, and Northaven Elementary schools. Approximately 190 students in Grades K-6 attend CIS of Clark County's "Extended Day Learning" afterschool program across the four sites. The average poverty rate, as evidenced by free/reduced lunch counts, is 73% across the four schools.
- Programming will be delivered by Mad Science of Kentucky, a leading science enrichment provider, delivering unique, hands-on science experiences for children that are entertaining and educational.
- Family "Science Nights" including:
 - Showcase of STEM projects that students have been working on
 - Refreshments
 - Student Recognition
 - Opportunities for children and families to participate in a special STEM project together
- Professional development for all CIS of Clark County afterschool staff. CIS of Clark County's
 afterschool programs are run by a team of over 50 dedicated staff members at 13 school sites.
 Duke Energy Foundation funding will expand STEM Professional Development for afterschool
 staff and provide needed resources for all 13 sites to implement additional STEM programming
 throughout the school year.
